#### **I. Welcome & Introductions – Senator Dan Kotowski**

The Chairman welcomed Commissioners and guests participating in Springfield, Chicago and by phone. At the Chairman's request, Commissioners introduce themselves.

#### **II. Review & Approval of Minutes – Senator Dan Kotowski**

#### **III. Agency Spotlight – Stephen Konya, Illinois Department of Public Health**

Stephen Konya, Chief of Staff for the Illinois Department of Public Health, updated the Commission on DPH's implementation of Budgeting for Results. Mr. Konya offered to circulate outcome data from the Illinois Performance Reporting System.

#### **IV. Pilot Update – John Kamis, Carpenter Lipps & Leland LLP**

John Kamis updated the Commission on Mission Measurement's efforts on the BFR Pilot in education. Mission Measurement previewed a preliminary section of the pilot. The Commission explored alternatives to the term "score card" and asked question about efficacy scores for programs. The commission asked the Pilot Sub Committee to continue to engage with Mission Measurement as the pilot moves forward.
