



Illinois Budgeting for Results Commission Meeting Minutes for October 25, 2024

Welcome and Introductions

Commissioner Clemons-Mosby called the meeting to order at 1:31 pm. Attendees gathered at the following locations:

Roll Call

Review and Vote on Final Draft 2024 BFR Commission Annual Report

Jennifer Butler, Deputy Director of Special Projects and Results Management at the Governor's Office of Management and Budget ("GOMB"), provided a review of the BFR Commission Annual Report for 2024. The report reviews the Commission's activities throughout the year. Commissioner Clemons-Mosby moved to approve the Annual Report with the addition of the Executive Summary and formatting updates. Commissioner Rivait seconded the motion. The motion passed by unanimous voice vote.
