

Illinois Budgeting for Results Commission Meeting Minutes for April 25, 2025

Welcome and Introductions

Commissioner Nolan called the meeting to order at 1:34 pm. Attendees gathered at the following locations:

Briefing on State Parks and Historic Sites Policy Domain

Adam Groner, Senior Economist at GOMB, provided a briefing on building a BFR Program Assessment Policy Domain for conservation and recreation. The commissioners held brief discussion after the presentation.

Update on The Benefit-Cost Analysis

Adam Groner, GOMB Economist, provided a briefing on the BFR Unit's program assessment activities, including new resources and avenues for further development of the Unit's program assessments and the benefit-cost model moving forward. The commissioners held brief discussion after the presentation.
