### Agenda

I. Welcome & Introductions – Senator Dan Kotowski

Chairman Senator Kotowski welcomed Commissioners and guests participating in Springfield, Chicago, and by phone. The Chairman asked Commissioners to introduce themselves.

II. Review & Approval of Minutes – Senator Dan Kotowski

The Commission approved minutes as presented with minor adjustments.

III. Pilot – Jacob Stuckey, Governor's Office of Management and Budget

Jacob Stuckey, from the Governor's Office of Management and Budget, updated the commission on the Pilot. Jacob believes the Pilot is to a place where it needs to be wrapped up. Mission Measurement is creating a memo on the Pilot, which should be finalized within a week and sent to Commissioners. Jason Saul, from Mission Measurement, outlined some of the findings from the Pilot, including lack of data and categorizing programs.

IV. BFR and the FY16 Budget – Ben Winick, Governor's Office of Management and Budget

Ben Winick, from the Governor's Office of Management and Budget updated the Commission on the preparation of the FY16 budget. Ben reported that budget letters are going to be sent out to agencies at the end of September or early October. It will ask the agencies to provide budgets organized by programs and by line items.
